- No trades are allowed.
- Only Awareness Campaigns /Promotional Events allowed at front lawn area.
- It is expected that the area be free of litter after the event.
- Only Frames tents allowed no pen tents or Kazimbo's.
- Tents may only be erected in the presence of Horticultural Assistant, Parks division.
- Please arrange with City Police /Traffic department about parking areas.
- Please provide your own generator, as there is no electricity in the park.
- It is expected to provide extra mobile toilets at your own cost.
- Ablution facility is under Cleaning contractor and id open on Saturday until 13h00 further arrangements can be made in advance
- No vehicles will be allowed inside the park, accept for loading purpose only.
- No music performance will be allowed in the front lawn area, use amphitheatre for music purpose.
- There will be no fire and braai's allowed. All stalls should be speedily dismantled and removed at the conclusion of the event.
- Please keep noise level low not to disturb business surrounding areas.
- Compulsory site meeting is expected wit relevant parties involved.
- All persons entering and /using the premises do so at own risk.

- City of Windhoek will be not being responsible for any lost/ theft of property or any injury.
  - Cancellation must be given in writing seven days before the event in order to get your refund.
  - Please adhere to the rules/ regulations of the park, as set out on the notice board at lower entrance.
- Non – compliance of the rules could result in approval of the future applications to be declined.
